The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2078/02/16 [May 30 ,2021] at the office of Bitthadchir Rural Municipality, Deulekh, Bajhang. Bids must be valid for a period of 30 days after bid opening and must be accompanied by a bid security amounting to a minimum of 25,425 which shall be valid for 30 days beyond the validity period of the bid.
